



2017 HALL OF FAME NOMINATION APPLICATION
Deadline: March 17, 2017 before 4 PM



The Anderson County Museum Hall of Fame recognizes people who have made outstanding contributions to Anderson County, its citizens and its way of life. Persons born in Anderson County who obtained recognition here, persons born in Anderson County who obtained recognition elsewhere and persons born elsewhere, but who made their home in and obtained esteem and recognition in Anderson County are eligible for induction. Nominees will be judged on a points system rating their contributions to the county and/or our nation/world. The judges will look at how the nominee advanced his/her particular field and the ways in which these advancements were made. A nominee need not be a resident of Anderson County; however, residency will earn a slightly higher rating in the judges' point system. Age, gender and race are not factors in the judging system process.

NOMINATING CRITERIA:

- a. Nominee must have been deceased for at least ten (10) years by nomination deadline.
- b. Nominee must have made contributions to one or more of the following: Anderson County, the history of Anderson County, or the history of South Carolina/United States/World.
- c. Nominee must have been an upstanding citizen of good moral character and may not have ever been convicted of a felony crime.
- d. Nominees need not have been residents of Anderson County.
- e. Supporting documentation (see tips page)

POINT SYSTEM FOR JUDGING NOMINEES: (*Total points attainable: 50*)

- a. Residency: **5 points for non-residents**
10 points for residents
- b. Contributions to Anderson County: **up to 10 points**
List candidates leadership or participation in city or county government, civic organizations, education system, business or corporate leadership, etc.
- c. Contributions to Anderson County History: **up to 20 points**
List candidates leadership or participation in activities that changed Anderson County's landscape, quality of life or position in the world at the time. Even more importantly, is this change still evident today? (i.e. candidate was on the founding committee of the first library, candidate started a business or organization that changed Anderson's quality of life or evolved into a large-scale employer). Perhaps the candidate served in government during a controversial time (a time of social change or when a large-scale project was agreed upon and completed.
- d. Contributions to State/National/World History: **up to 10 points**

GENERAL INFORMATION:

- a. There may be up to two inductees per year. *There may be a year with no inductions if the judges determine that none of the nominees qualify for induction.*
- b. For each class there is no limit to the number of Nominations that can be considered.
- c. If not selected for induction, a previous nominee's application will automatically be carried to the next selection round. Applicants should review their nominations regularly to insure that any new information is added.
- d. Applicants may nominate more than one candidate.
- e. More than one applicant may nominate the same candidate. Before submitting a nomination form, it is advisable to review a current list of nominees available in the Museum's Reading Room.
- f. It is expected that **10 copies** of the nomination form and all supporting documentation be provided to the Museum Staff.

Deadline: March 17, 2017 before 4 PM

Completely fill out the nomination form and submit it by the deadline

- a. Be thorough. Don't assume everyone knows details about your nominee just because the name may be familiar.
- b. DOCUMENTATION! Supporting documents validate your Nominee's credentials. Even a simple obituary can be significant! It may list several of your Nominee's accomplishments. Supporting documents can include newspaper clippings, excerpts from books, family documents, photographs, diaries, etc.
- c. Refer to the resources listed if more documentation is needed.
- d. Review previously submitted applications (Anderson County Museum Reading Room.)
- e. The list of excellent nominees gets longer every year. If it takes several years for "your" nominee to be selected, be patient, and if you know there is more information available on your Nominee, take the time to have it added!
